BCCC/1024/07 Developing Biodiversity & Climate Change (BCC) Section of Council Business Plan

a) Council Business Plan - Council Watts advised that this Committee would be responsible for setting priorities and projects that effectively deploys Council resources to minimise climate change impact and enhance local biodiversity.

b) Pilsley Carbon Footprint – the Committee considered the report detailing Pilsley 's current impact and work already carried out. It was **Resolved:**

- To collate a list of local cost, quick wins that could be delivered through the Council's own resources.
- To collate list of large scale projects for inclusion in the Council's business plan and seek external funding. These projects to include:
 - a. Morton Park renovation project
 - b. Solar thermal heating solutions
 - c. Battery packs
 - d. Village insulation
 - e. Community composting
 - f. Car charging point
 - g. Solar panels on Council owned building
 - h. Environmental feasibility study to ascertain options to generate electricity.
- c) Pilsley Heritage Windmill the Committee discussed the potential of this site and the challenges
